- C) The provision of this service will have an initial **duration of 1 year** from the date of contract formalization, with the **possibility of 1-year extension**. If approved by VHIR as the contracting entity, the extension will be compulsory for the contractor in accordance with the provisions of article 29 of the LCSP.
