RESOLVED:

First.- To raise the award of the contract relating to the contracting of an innovation software management for the Innovation Unit of the Fundació Hospital Universitari Vall Hebron - Institut de Recerca (VHIR), to the following company:

- 16.000,00 € (VAT excluded) for the first year.

An appeal for reversal may be lodged with the Contracting Body within one month of the day following notification, in accordance with Article 77 of Law 26/2010, of 3 August, on the legal and procedural regime of the public administrations of Catalonia, and in accordance with Article 123 of Law 39/2015, of 1 October, on Common Administrative Procedure for Public Administrations, of 1 October, on the Common Administrative Procedure of Public Administrations, or be directly challenged before the contentious-administrative jurisdiction, in accordance with the provisions of Law 29/1998, of 13 July, regulating contentious-administrative jurisdiction.
