Nuclear Medicine Department uses radioactive substances (radiopharmaceuticals) for the diagnosis (mainly by imaging based techniques) or treatment of medical conditions. In Vall d'Hebron University Hospital the Department is located on Level 0-Area C of the main building.

Our team consists of a variety of highly-trained healthcare professionals who work together, including Nuclear Medicine physicians, cardiologists, radiologists, radiopharmacists, physicists, Nuclear Medicine technologists, nurses, orderly and administrative staff.


Performing approximately 29000 nuclear medicine procedures each year, we are one the largest single-site nuclear medicine unit in Spain, undertaking a huge range of clinical and research scans (scintigraphy/SPECT, PET/CT and DEXA), sentinel lymph node identification and other radioguided surgery techniques and more than 600 nuclear medicine treatments.




