


Main responsibilities and duties:

The Paediatric Haematology and Oncology Division of Vall d'Hebron Hospital treats around 120 children and adolescents with cancer as well as up to 500 new patients with haematological conditions and performs 40 stem cell transplantations per year. All research is conducted through the Childhood cancer and blood disorders Group of VHIR. There are more than 60 trials open (early phase/late phase/observational studies). The candidate will join a very active team of 14 paediatric haematology and oncology consultants, 2 study coordinators 2 data managers and 2 research nurses.

- Conduct thorough assessments of pediatric oncology patients' nutritional status, considering their medical history, treatment plan, and dietary habits.
- Develop comprehensive, tailored nutrition care plans for each patient.
- Nutritional education and counseling.
- Monitor patients' nutritional status and progress regularly, tracking changes in weight, dietary intake, and biochemical markers. Adjust nutrition interventions as needed based on evolving needs, treatment responses, and clinical outcomes.
- Work collaboratively with oncologists, nurses, social workers, and other members of the healthcare team to ensure coordinated and holistic care for pediatric oncology patients.


